BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF FROMBERG, MONTANA AS FOLLOWS:

- SECTION 1: That the Fromberg Municipal Code, the original of which is hereto annexed, which shall henceforth be considered the official text of the Fromberg Municipal Code.
- SECTION 2: Official text-there shall be but one official text of the Fromberg Municipal Code, and any discrepancies in the official text and any other copies thereof shall be controled by the wording of the official text.
- SECTION 3: CHANGES: All changes in the Ordinances of the Town of Fromberg, which shall effect the Fromberg Municipal Code shall include therein the title and section numbers which will be changed, and all new ordinances shall be immediately codified and shall be made part of the Fromberg Municipal Code. All ordinances inconsistent with any statements or ordinances in the Fromberg Municipal Code are herewith repealed. All sections of the Code which were not previously ordained as ordinances of the Town of Fromberg, are herewith adopted and the same shall be the law of the Town of Fromberg as if it had been completely ordained, and is to be considered hereby to be ordained as the law and ordinances of the Town of Fromberg.

ORDINANCE NO. 156

AN ORDINANCE TO AMEND THE FROMBERG MUNICIPAL CODE TO CREATE CHAPTER 7 OF TITLE 6 THEREOF, ENTITLED "DANCES" AND REQUIRING A LICENSE TO HOLD A DANCE WITHIN THE TOWN LIMITS OF THE TOWN OF FROMBERG WHICH WILL HAVE LIVE MUSIC, ^{OR ALCOHOLIC BEVERAGES SERVED} WHEN ANY SUCH DANCE WILL BE OPEN TO THE PUBLIC, AND SETTING A FEE THEREFORE.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF FROMBERG AS FOLLOWS:

Section 01. Public Dances. It shall be unlawful to hold any dance within the Town of Fromberg, open to the public, at which music will be provided by live musicians, ^{or at which alcohol is served} unless the individual or group sponsoring such dance shall have first obtained a permit for the purpose of said dance from the Town Clerk of the Town of Fromberg.

Section 02. Fees. A license fee of \$50.00 shall be paid by any party requesting a license to hold a public dance.

Section 03. Police Protection. The Town of Fromberg shall hire, and the sponsoring group shall allow upon the premises, a police officer who shall keep the peace, and who shall ^{arrest} any party who violates any of the ordinances of the Town of Fromberg, or the State of Montana.

Section 04. Time of Dance. No dance open to the public shall be allowed to continue after the hour of 12:00 o'clock A.M.

Section 05. Application Requirements. The application for a dance license under the provisions of this Ordinance shall state the name of the group sponsoring the dance, or name of individual, the date of the dance, the hours of the dance, and the names of musicians, which may be in the form of the name of the group of musicians.

Section 06. Denial of License. A license under the provisions of this Ordinance may be denied for any of the following reasons:

a) The Group sponsoring the dance applied for, sponsored a dance within the past year in violation of the provisions of this ordinance. This shall apply to individuals as well.


b) Any member of the band which will provide the live music has been arrested for disturbance

Ord #156

during a previous live music engagement in the Town.

- c) Upon affirmative action of the Town Council, of which the person or group making application must be given reasonable notice, the right to receipt of the sponsoring group or individual has been revoked, as a result of drinking by ~~drinking~~ minors at the last sponsored dance or as a result of disturbance being caused at the premises which could not be handled and stopped by the police officer on duty.

Section 08. Penalty. Any person who violates any of the provisions of this ordinance shall be guilty of a misdemeanor and subject to the general penalty provisions of the Fromberg Municipal Code.



SEC. 01. That the provisions of Ordinance No. 156 enacted on the 6th day of July, 1976, are hereby suspended for a period of ninety days.

Section 02: That this suspension is for the purpose of allowing voluntary compliance with the requirements of the town of Fromberg, for the hiring of policemen and police protection upon said property and with the understanding that alcoholic beverages will not be served in buildings that are rented out for public dances.

Section 03: Emergency Ordinance. It is felt that this Ordinance is an emergency ordinance as there are considerable number of people in the town that are upset with the provisions hereof and that it's provisions should go into effect immediately.

AN ORDINANCE REGULATING THE CONTROL OF DOGS, PROVIDING FOR THEIR SEIZURE AND DISPOSITION, AND PROVIDING A PENALTY FOR THEIR OWNERS FOR VIOLATIONS.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF FROMBERG, MONTANA, THAT:

SECTION I:

It is unlawful to permit any dog to run at large within the Town limits of the Town of Fromberg.

SECTION II:

All dogs shall be confined on the private property of the owner of the dog, or be within the actual physical control of said owner at all times of the night or day.

SECTION III:

Any law enforcement officer shall seize and impound any dog found within the town limits which is not on the private premises of its owner or within the actual physical control of the owner. The impounding officer shall give reasonable notice of the impoundment of the dog to its owner, in compliance with the Fromberg Municipal Code, and shall proceed to dispose of any such animal so impounded after it has been impounded for a total of five (5) days.

SECTION IV:

All owners of dogs who allow their animals to run at large in violation of the Fromberg Municipal Code shall be guilty of a misdemeanor.

SECTION V:

Upon finding of guilt, party so found shall be subject to the following penalty.

1st offense - \$ 5.00
2nd offense - 10.00
3rd offense - 20.00

Upon passage, this ordinance will be codified in the Fromberg


Be it ordained by the Town Council of the Town of Fromberg:

An ordinance amending the Fromberg Municipal Code as provided for by the Fromberg Government Review, and changing Title 2, Chapter 1, Section 01, the effect of which is to create, at large, elections for aldermen.

Section 2-1-01 of the Fromberg Municipal Code shall be amended as follows:


2-1-01 ELECTIVE AND APPOINTIVE OFFICES. The officers of the town shall consist of one mayor and four aldermen, who shall be elected at large by the qualified electors of the town. There may be appointed by the mayor, with the advice and consent of the council, one clerk, who may be ex officio assessor and a member of the council, and one treasurer, who may be ex officio tax collector, and one marshall, who may be ex officio street commissioner, and any other officers necessary to carry out the provisions of the municipal ordinances and state law. (R.C.M. 11-703).

ORDINANCE NO. 165

Be it ordained by the Town Council of the Town of Fromberg:

An ordinance amending the Fromberg Municipal Code as provided for by the Fromberg Government Review, and changing Title 2, Chapter 1, Section 04, the effect of which is to eliminate wards.

Section 2-1-04 of the Fromberg Municipal Code shall be amended as follows:

2-1-04 VACANCY OF OFFICE. If any officer, either elected or appointed to office, fails for ten days to qualify as required by law, or enter upon his duties at the time fixed by law, then such office becomes vacant; or if any officer absents himself from the municipality continuously for ten days without the consent of the council, or openly neglects or refuses to discharge his duties, such office may be by the council declared vacant; or if any officer removes from the municipality, or any alderman from the municipality, such office must be by the council declared vacant. (R.C.M. 11-719).

ORDINANCE NO. 166

Be it ordained by the Town Council of the Town of Fromberg:

An ordinance amending the Fromberg Municipal Code as provided for by the Fromberg Government Review and changing Title 2, Chapter 1, Section 05, the effect of which is to eliminate wards.

Section 2-1-05 of the Fromberg Municipal Code shall be amended as follows:

2-1-05 FILLING VACANCY IN ELECTIVE OFFICE. When any vacancy occurs in any elective office, the council, by a majority vote of the members, may fill the same for the unexpired term, and until the qualification of the successor. If the council shall fail to fill such vacancy before the time for the next election, the qualified electors of such municipality may nominate and elect a successor to such office. (R.C.M. 11-721).
